



6. The Managing Trustee shall have power to administer the fund of the Trust and any power exercisable by Trust Board may be delegated to Managing Trustee.

9. That, proper accounts for the Trust shall be kept and shall be open to inspection by the Trustees.
10. That, the financial year of the Trust shall be April to March with option of the Trustee to change the same if they so deem fit. The Trustees shall have their accounts audited every year by a Chartered Accountant or a firm of Chartered Accountants.
11. That, the initial contribution of Rs. 11,000/- (Eleven Thousand) in cash made by the settlers shall hereby vest in the Trustees, and shall constitute initial Trust fund.
12. That, the funds of the Trust shall not be applied for any purpose other than the objects of the Trust stated in the Para 13 below.



(ii) Without prejudice to the generity of clause (i) the objects of the Trust shall be all or any of the following objects without any distinction of caste, creed or sex. that is to say:

- (d) For the advancement of physical education including establishment, maintenance and support of gymnasium and other institution for the Promotion of physical fitness.
- (c) Generally for the advancement and propagation of education by any means e.g. publication of books & Granths for Character Building, Literature, Humanity and on all other useful subjects in all their manifestation.
- (iii) In giving medical relief including the establishment maintenance and supports of institutions or fund for medical relief such as hospitals, dispensaries, aushadhalayas or other institutions or funds having amongst their objects such medical relief so that under such institutions or funds such relief shall be otherwise available.
- (iv) For the purpose of the relief of the poor including for that purpose the establishment and maintenance of houses for feeding the poor and support of institutions or funds having amongst their objects the relief of any form of property so that under such institutions or funds such relief shall be otherwise available.
- (v) Without prejudice to the generality of clause (iv) above for any of the following objects, that is to say:-
- (a) For erecting or helping in the erection of building or otherwise providing housing accommodation to or for the benefit of poor person at any place in India at cheap rents or license fees.
- (b) For making available to poor person the benefit of a Sanatorium, or health home or home for rest and recreation at any place in India or otherwise for making available to poor persons the benefit of a change of air on rent which they are unable to secure by their own private means.
- (c) For helping poor boys and girls for payment of fees or charges in respect of school, colleges or other educational institution or for providing books or for defraying other expenses of such students.
- (d) For giving monetary help to poor and deserving people including help in cases of illness in the family or otherwise rendering free medical aid to the poor, old and infirm people and/or destitute.
- (e) To give, provide and/or render food, cloth or other articles of necessity and facilities and other help and/or assistance in any shape or form to the poor, -deserving and needy person.



- (i) To give, provide and/or render help and assistance in cash or kind to the poor widows.
- (vi) To give, provide and/or render help and assistance in cash or kind for the marriage of poor girls.
- (vii) For the advancement of any other subject of general public utility not involving the carrying on of any activity for profit.
- (viii) To support, grant, aid and donate money to any fund, object, institution and/or institution establishment or engaged for advancement of any public charitable purposes within the meaning of Income Tax Act, 1961 or any amendments made there under.
- (ix) To take up or fulfill such other charitable purposes as may be deemed fit by the Trustees and to do or cause to be done all such acts, deeds or things as may be deemed fit and proper for or in connection with all or any of the objects with all or any of the objects of the Trust and/or for better Administration and Management of the Trust provided always that is hereby declared that if any one or more of the objects specified above are held not to be objects of the public or charitable nature, it shall be assumed as if the same are not incorporated in these presents and the validity of the Trust created by these presents as a Trust for public and charitable purpose shall not be effected in any member.
- (x) Enforcement of charity for the weaker section of women.
14. That the Trust properties shall consist of the following:-
- (i) The Schedule 'A' property given as corpus of the Trust by the settlers.
- (ii) Donation, which the Trust may receive from any person including the Trustees.
- (iii) Any property acquired with the Trust Fund.
15. That, the Trust Board shall have the power to acquire immovable and movable properties.
16. The Board of Trustees shall meet as often as may be necessary or convenient to transact business of the Trust.

17. That, all decision of the Board of Trustees shall be taken either unanimously or by majority and if the Board is equally divided, the Managing Trustee will have the casting vote.
18. That, the Management and Administration of the Trust shall vest in the Board of Trustees.
19. That, in case of death of any Trustee or in the event of the Trustee being declared insolvent or in any event if he or she being incapacitated physically to work properly as Trustee or due to any other reason as stated in Para 20 below, the other Trustees shall be at liberty to co-opt. Any person of good repute as Trustee of the said Trust, in place thereof.
20. That, a Trustee shall cease to be such:-
 - (i) On his/her death.
 - (ii) On his being declared as insolvent by a competent court.
 - (iii) On his being convicted by a criminal court for an offence involving moral turpitude.
 - (iv) On his becoming insane.
 - (v) On his resignation from the Trust as Trustee and acceptance of such resignation by the Trust Board.
21. That, rules may be framed for the proper Administration of the Trust but such rule shall not be against the objects of the Trust as in Para 13 above.
22. That, the Trust Board shall have power to borrow money for the purpose of Trust.
23. That, for removable of doubt it is hereby declared that this Trust, its objects and its implementation shall not be for the benefit of any particular caste or religious community as such.
24. That, all acts and proceedings of the Trust shall be taken and conducted in the name of the Trust.
25. On dissolution of Trust.
26. If and so often as any of the Trustees of these presents shall die or be abroad for more than two years or become bankrupt or insolvents or desire to be discharged from or refuse or neglect or become incapable or unfit to act in the Trusts of these presents or if shall be desire to appoint an additional Trustee or Trustees, it shall be lawful for the surviving or continuing Trustees if willing to act and failing them for the heirs, Executors or Administrator of the last surviving Trustee in the place of the Trustee or Trustees so dead or being abroad for more than two years or becoming bankrupt or insolvent or desiring to be discharged or refusing or neglecting or becoming incapable
